

Editorial Ethics of Journal

1.1. The editors of the scientific and methodological journal “Physical Education and Sports Training” guarantee an objective, impartial review of all materials for publication relevant to its subject matter for the purpose of expert evaluation (regardless of the national, religious, gender, and other authors).

1.2. Previously unpublished articles on the directions of the presented rubrics in Russian or English, the results of fundamental and applied scientific research, reviews, as well as the scientific results of dissertations for the candidate and doctor of science degrees, corresponding to are accepted for consideration:

- ✓ journal topics
- ✓ rules for sending manuscripts of articles
- ✓ rules for reviewing articles manuscripts
- ✓ rules for manuscripts of articles.

➡ **Not allowed to consider:**

- ✓ articles designed without complying with the rules for manuscripts;
- ✓ Articles containing more than 25% of borrowed text from open sources.

Publication of articles is free. Author’s fee is not paid.

The editors check the articles submitted for consideration with the help of the Antiplagiat system.

1.3. *The main criteria influencing the decision of the editorial board to include / reject articles submitted for publication are:*

- relevance of scientific research
- scientific novelty of research
- completeness and consistency of the presentation of research results
- reliability of research results
- completeness and validity of the findings.

1.4. The editors consider the manuscript as a confidential document. This means that information or ideas obtained in the process of reviewing and preparing an article for publication must remain confidential and cannot be used for personal gain, the benefits of other individuals or organizations. Unpublished data obtained from submitted manuscripts may be used in personal research only with the written consent of the author.

The editors receive consent from the authors to use their personal data exclusively for contacts with them.

The editors maintain the confidentiality of the personal data of the reviewers.

1.5. *The review of the declared materials with the purpose of their expert evaluation is carried out according to the following principle:*

- the editors send for review all received materials, including from members of the editorial board;
- The reviewer is appointed by the editors from among the recognized experts on the subject of peer-reviewed materials who have published publications on the subject of the article under review for the last 3 years. The expert committee of the Academy for reviewing scientific articles includes highly qualified specialists – professors, doctors of science;
 - co-authors of the article, scientific leaders, and authors' consultants cannot be appointed as reviewers;
 - to ensure the greatest objectivity, peer review is one-sided anonymous;
 - when reviewing articles, reviewers involved by the editorial staff are obliged to avoid personal criticism and make only reasoned conclusions;
 - until the moment of publication, the materials submitted to the editors are the property of the authors and refer to information that is not to be disclosed. Reviewers are not allowed to use the materials provided in any way;
 - articles are sent to the external closed review no more than two times. Articles for which a negative review has been received are withdrawn from consideration. The authors are obliged to take into account all the comments of the reviewer when finalizing the article. If the author disagrees with the comments of the reviewer, he should write a reasoned answer;
 - reviews and responses to them should not contain insults, slander, etc .;
 - at the request of the author, the editors send him a copy of the review or a motivated refusal;
 - the editors are obliged to send copies of the reviews, upon request, to the Ministry of Education and Science of the Russian Federation;
 - The final decision on whether to accept the article for publication is made by the editorial board.

1.6. *The authors are responsible for the scientific content of the article and guarantee:*

- strict compliance with the required version of the rules of writing and design articles for publication in the journal;
- the originality of the material – not less than 75 %;
- no article materials not to be published in the press, in accordance with the applicable regulations;
- commitment not to publish articles in other printed and / or electronic editions of more than 50 %;
- the contents of the articles of references to the cited authors and publications, the results and facts obtained by other authors or organizations in accordance with applicable copyright laws;

- notice amended if errors are found in already published article.

1.7. The *authors agree that editorial Board has the right to:*

- remove from consideration articles that do not meet the profile of the magazine;
- require original research if editors or reviewers have any questions or concerns;
- to make cuts and editorial changes to the text of the manuscript;
- submit material articles in Russian and foreign organizations providing indices of scientific citing;
- do not return the manuscript.

1.8. Received personal data of the authors, with the exception of the information mandatory for publication, is not provided to third parties and organizations.
